Komatsu Australia Pty Ltd (Komatsu) – ‘Win a Seadoo’ (Promotion)

Purchase any Komatsu Premium Used machine from Komatsu between 12:00am AEDT on 17 November 2025 and 11:59pm AEDT on 8 March 2026 (**Eligible Order**) and automatically go into the draw (**Eligible Entry**) to win 1 of 1 brand new 2026 Sea-Doo GTR 230, 36TB (valued at AUD24,000 incl GST) (**Prize**).
2. One entry per Eligible Order, any additional Eligible Orders made during the Offer Period will also be eligible to enter the Promotion.
