Apprenticeship AUR31220 Certificate III in Mobile Plant Technology

This qualification covers the skills and knowledge required to perform a broad range of tasks on a variety of mobile plant vehicles in the automotive service and repair industry. It is suitable for entry into the mining, construction and agricultural environment.

A Mobile Plant Mechanic is involved in servicing, repairing, overhauling and maintaining mobile heavy equipment such as highway transport vehicles, construction and earth moving equipment, tractors and mobile industrial equipment.

Note: You will need to be employed and registered as an apprentice before you can undertake this course. This course may also be available through Recognition of Prior Learning to eligible applicants.



Apprenticeship AUR30320 - Certificate III in Automotive Electrical Technology

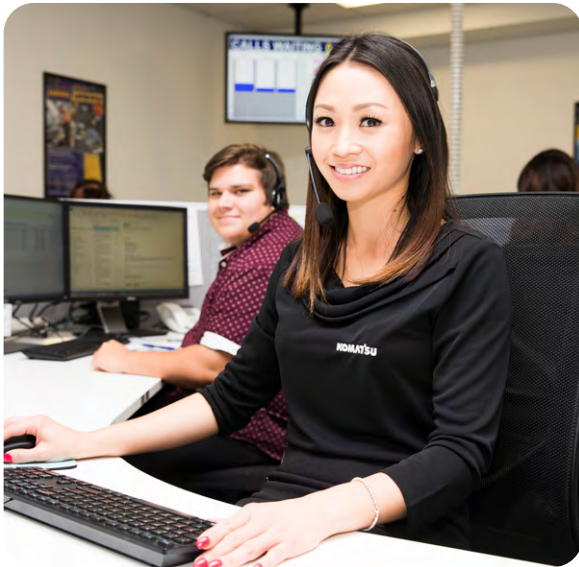
This qualification is designed to provide an industry recognised skills profile related to trade work as an Automotive Electrical Technology Tradesperson.

The Certificate III in Automotive Electrical Technology gives you the training you need to start your career as a qualified automotive (electrical technology) tradesperson.

You will learn how to service, diagnose and repair vehicle electrical and electronic systems and components.

This qualification provides great scope for future work in both the automotive electrics and automotive technology related industries.

Note: You will need to be employed and registered as an apprentice before you can undertake this course. This course may also be available through Recognition of Prior Learning to eligible applicants.



Traineeship BSB30120 Certificate III in Business

This nationally recognised qualification is delivered as a traineeship and is designed to provide you with the skills and knowledge to develop a broad range of business skills to kick-start your career and may be delivered via blended delivery (which is both face to face and on-the-job training methodologies).

If you work in a business support role, this is the ideal course to bring you up to speed with the latest business and computing skills. It will help you become more efficient in your day-to-day operations and improve your confidence in dealing with the technology, regulations and legislation which affects business operations.

Note: You will need to be employed and registered as a trainee before you can undertake this course. This course may also be available through Recognition of Prior Learning to eligible applicants.

Effective from 1st January 2020, the WA Government has halved course fees for certain targeted vocational qualifications including: AUR31220 Cert III in Mobile Plant Technology. This initiative means that:

- \$400 for concession students and people aged 15-24
- \$1,200 for non-concession students
- Any units of competency commenced outside of this period will attract the regular course fees.

** For further clarification on fee caps for Lower Fees/Local Skills Program refer to below:

People entitled to a concession course fee cap include:

- All students aged 15—24**
- Persons and dependents of persons holding: a pensioner concession card; a repatriation health benefits card issued by the Department of Veterans' Affairs; a Health Care Card; persons and dependents of persons in receipt of the Youth Allowance, AUSTUDY or ABSTUDY; dependents of persons who are inmates of a custodial institution or Secondary school-aged persons, not enrolled at school.

** Note: Students aged between 18 –24 that do not fit into one of the other categories will be required to pay non-concession fee rates up to max \$400

It is important to note that only a 'New Worker' that is someone who has been employed in a Full-Time capacity for a period of under 3 months will be eligible for funding under this Traineeship. 'Existing workers' entering into BSB30120 will not be eligible for either State or Federal Government based Incentives.

Eligibility requirements (the same apply for both Apprenticeships and Traineeships):

- Must be an Australian Citizen (or hold a relevant Australian Visa or Permanent Residency)
- May be a New Zealand Citizen (if living in Australia for more than 6 months)
- Be over 15 years of age
- Must reside and work in Western Australia
- Be in, or entering into Part Time or Full-Time employment with an Employer in the same industry related area
