References to “you” in this statement mean the applicant for finance (which includes, any form of leasing or advancing of money on an unsecured or secured basis) (“applicant”), a guarantor, a prospective guarantor and, if the applicant is a company, any director or other officer of that company.

## PERSONAL INFORMATION

### YOUR RIGHTS

- You may choose not to give us your personal information. However, without this information we may not be able to process the applicant’s application for finance continue to provide such finance and/or provide you with an appropriate level of service.
- You may request access to any personal information we hold about you. You may also request that we disclose the identity of any person to whom we have disclosed your personal information. We will process each request you make in accordance with the Australian Privacy Principles. No fee will be charged by us to you for complying with any such request. However, we may charge you for reasonable out of pocket expenses (e.g. photocopying costs) and other expenses we incur in giving you any information you have requested. In some cases we may refuse to give you access to certain information where this is permitted or required by law.
- If we refuse to give you access to any information we will provide you with reasons for our refusal. If you request us to do so, we will take reasonable steps to amend any personal information about you held by us which we agree is inaccurate, incomplete or out of date. If we disagree with you about the accuracy, completeness or currency of a record of your personal information held by us, we will take reasonable steps to note with that record a statement to the effect that you claim this to be the case, if you request us to do so.
